

# MANAGEMENT OF ADMINISTRATIVE SANCTIONS FOR VIOLATIONS OF THE HIGHWAY CODE

Road safety, technologies and solutions to support the local police and to protect citizens and the environment.

## APPROACH

Local Authorities must be committed and act on the issue of road safety due to the economic impacts and implications, above all the social ones, that it has on the entire community. At the same time, they must sanction violations whilst countering the widespread attitude of hostility and act to improve security, including by using the proceeds of the sanctions. A substantial percentage of the resulting Revenues, in fact, is restricted to be used for the management, maintenance and control of the roads, for safety improvement and for educating citizens in behaviours well-suited to civil coexistence.

## SOLUTION

Software, services and equipment for the automatic detection of fines which fully meet the needs of Local Authorities, covering not only the management chain of infringements of the Highway Code - and of all administrative sanctions in general - but also the obligations towards road accidents, the permit management for restricted traffic zones and supporting the Authority in the management of offenders residing abroad. Ancillary services that allow administering the many legal disputes generated with the sanctioning activity and offering solutions for road education.

- Single and/or multiple registration of fines.
- Validation of the fines acquired by electronic equipment through the preview of the photographic image.
- Online consultations through WebServices with the Department of Motor Vehicles and Public Vehicle Register for the individual recovery of vehicle owners.
- Printout of fines on A4 form with automatic archiving in document folder of the original in PDF.
- Massive remote signing service of the fines produced.
- Recovery of Certified email (PEC) addresses from INI-PEC.
- Notification via certified email (PEC).

## SMART FINES

**IT IS A NATIVE ANDROID APP, A DAILY WORK TOOL FOR ASSESSING OFFICERS. IT IS POSSIBLE:**

- To verify in real time information useful for the control process, thanks to the integration with the central platform.
- To quickly issue sanctions for violations of the Highway Code or other violations.
- To attach photographic evidence, documents, notes and GPS position to the notification.
- To manage payments on the road.
- To receive alerts for the parking areas to be checked.
- To send reports within the urban area.



## ADVANTAGES

### ANALYSES

Possibility of analysing territorial data on sanctions and accident rate.

### PRE-SET FORMS

Preparation of the request to the Prefect for the authorisation of new equipment.

### SUPPLY

Supply or rental of all the equipment for detecting fines (speed, traffic light, restricted traffic zone).

Complete, quick and effective management of the fine process even for residents abroad.

### CONSULTATIONS

Consultations, payments and online communications by the sanctioned subjects.
