APPROACH

With the decline of derived finance as the main source of livelihood, Local Authorities must mainly independently find the sources to be used to achieve their institutional purposes and to provide services aimed at satisfying the needs of citizens and businesses. However, no use is possible without the necessary economic resources. The management of own Revenues has thus become a fundamental hub for guaranteeing the resources required for the city's operation and for the efficiency of the services provided.

SOLUTION

Skills in processes, applicable legislation and the most modern technological tools are the pillars on which the services and application solutions for revenue management and territorial governance are built. The same elements allow carrying out innovative projects integrated with the management systems already in use. - **Complete management of the processes** for the assessment and collection of Revenue.
- **Improve knowledge of the territory** (personal data of subjects, toponymy, properties) thanks to the integration of the municipal information system with the Knowledge System.
- **Development of apps** for mobile devices and websites to encourage dialogue between citizens and the Administration.
